That Note.

Rumors Concerning Its Transmission Are Premature.

It May Not Be Presented Before Sunday.

Report That 2,000 Mussulmans Have Been Massacred Near Selino.

The New York Herald's correspondent at Constantinople cables as follows: All the rumors concerning the transmission of a collective note by the ambassadors, accompanied by an ultimatum, from here to Greece, are premature. Today the ambassadors here had not even received the terms in which this note is to be couched. Consequently, the opinion is that, owing to the near approach of the Balm festival, on Thursday, the eventual transmission could hardly be made before Sunday. It is no longer doubted here that this note will be accepted by the Porte. Meanwhile, the Greeks by Greece by that time will be induced to accept it. The ambassadors continue to use all their efforts to persuade the Sultan to cease his armaments.

AND RUSSIA BROKEN OFF.

London, March 2.—A dispatch to the Times from Cana says: "The fall of Candia has caused a complete rupture of relations between the Greeks and the hamman population here, who have appealed to the Greek Vice-Consul to send them arms and ammunition. He has agreed to do this on condition that the admirals supply the means to enable them to proceed to Selino, and that the civil Governor, Kimsay Pasha, gives a written order to the Turks to quit Candia under the Greek guarantee of safety."
