JAPAN'S STRAIGHT TALK TO RUSSIA

Will Fight to the Death For Corea—The Manchurian Evacuation.

London, Oct. 6. — No apprehensions exist in official circles that the far eastern situation will bring forth any immediate serious developments. This feeling of temporary security on the eve of the date that Russia would, but admittedly will not, evacuate Manchuria, is due to assurances on the part of the Japanese that so long as negotiations now proceeding between herself and Russia present a reasonable prospect that a settlement will be reached, Japan will take no action hostile to Russia in the matter of Manchuria. It is further learned that those negotiations looking to a final settlement of the Russo-Japanese spheres of influence in the far east, and especially dealing with the situation in Corea, are progressing satisfactorily at Tokio. The negotiations will probably not be concluded by Oct. 8, the date on which Russia was to evacuate Manchuria, but this will not precipitate a diplomatic crisis.

Such developments of immediate danger as the far eastern situation presents, appears to be confined solely to the popular agitation in Japan against Russia, after Oct. 8. This, however, is being taken into consideration by the Japanese Government, whose diplomats have warned Russia that while the Japanese Government will not allow itself to be forced to the extent of entering into hostilities over the Manchurian evacuation question, it cannot indefinitely tolerate the present negotiations at Tokio in face of the expected popular clamor.

From the Japanese embassy in London a statement has been obtained, which says: "From Japan's point of view the crisis of the whole situation is Corea. Russia knows that we will fight to the death rather than let any foreign power occupy Corea. Russia's further concessions and the other recent encroachments in Corea render the present negotiations extremely difficult, but the Japanese Government is cognizant of the trend of our present negotiations, all of which look toward peace. We have no reason to believe that Russia's activity in securing dockyards for her fleet is intended to be a preparation to prepare for hostilities, any more than are our own necessary provisions for our navy and army."

Many Good Samples of Grain Shown — Some Inferior Qualities Rejected.

Toronto, Oct. 6. — Standards for grain grown east of Port Arthur were yesterday fixed by the board appointed by the Dominion Government, consisting of W. D. Matthews, chairman; Thos. Fyfe, D. L. Spink, John Carlick, C. B. Watts, of Toronto; John I. A. Hunt, of London; James Dunlop, of Hamilton; William Brodie, of Quebec; F. Craig, chief Dominion grain inspector, Montreal; E. Adamson, chief grain inspector, Toronto, and J. Hurley, grain inspector, at Peterboro.
