## ITALO-ETHIOPIAN WAR—SANCTIONS

Mr. CHURCH:

1. On what date were sanctions agreed to and put into effect by Canada against Italy because of Italy's invasion of Ethiopia?

2. When were sanctions withdrawn by Canada?

3. Will the text of (1) and (2) be laid on the table of the house?

4. Has Canada approved or been asked to approve of the conquest of Ethiopia by Italy?

5. Has Italy or the government of Great Britain asked Canada's approval?

6. Will all communications relating to questions four and five be laid on the table of the house?

Mr. MACKENZIE KING: This stands as an order for return, tabled herewith, I am asking that the question should be made an order for a return because there is an order in council attached to the answer which I am anxious to table.

1. What was the approximate value of the market garden products exported to the United States during the twelve months ending December 31, 1937?

2. What was the value of market garden products imported into Canada from the United States during the same period?

3. What proportion of this amount was imported into Ontario?

4. What was the approximate value of the same production of this produce in Canada during the same period?

5. What proportion of this amount was produced in Ontario?

## EXPENDITURES ON LEVEL CROSSINGS

1. On what level crossings in Canada was: (a) the grade crossing fund expended; (b) the special million dollar 1937 vote for that purpose expended?

2. Will the minister give the house details of expenditures in each case?

Subject, however, to communications of that nature not being tabled, the government has no objection to the motion being carried.
