Mr. Dufresne: My hon. friends' enthusiasm may cool down a bit when they have taken a good look at what two Ottawa ministers are doing to the one who represents them in Quebec. Does it not look as if they are in the process of putting handcuffs on the Liberal party leader in Quebec, just as if he were the slave of his Ottawa masters?

That remark by the hon. member for St. Mary is a cowardly remark, and could only be spoken by a coward such as the hon. member for St. Mary. I hope he will have the courage to repeat outside the house what he just said. Fat-head! No wonder the people of Quebec keep repeating just now "Like father, like son". The hon. member for Dollard (Mr. Rouleau) is not quite as brave as he would have us believe. He is more often behind the curtains than in front of them.

Mr. Chairman, we have asked that the matter be referred to committee, and we will keep on asking it, in the hope that our request will be granted, if there is a little freedom left in this house.

Judging by the press reports we read every day, the people of Canada favour the opposition, the Conservative party, which is now fighting mightily to secure the necessary

information in connection with the bill now before the house. Mr. Howe (Port Arthur): I have a correction that has to do with the figures I gave on the cost of gas. The figures appearing on page 4426 of Hansard for May 29, at the end of column 1 and the beginning of column 2, relating to interruptible gas are in error. They were quoted as being the current revised rates, but were read from an unrevised tabulation. The following are the figures quoted, followed by the correct current revised figures: For Manitoba I said 23 cents and it should be 18 cents; western Ontario, 28 cents should be 25 cents; northern Ontario, 32 cents should be 29.5 cents; central Ontario. 33 cents should be 30 cents; eastern Ontario, 33 cents should be 30.5 cents. Hon. members will find that the figures appearing on page 4428 are correctly stated.

Mr. Michener: I have been looking at the corrected figures and I should like to draw the attention of the minister to the fact that this statement appears on page 4428 of *Hansard* for May 29, in the second column:

During the first three years only, gas may be accepted at Canadian-United States border at 75 per cent load factor, with price payable to Trans-Canada 27.27 cents per MCF.
