ALBERTA-CONSERVATION OF WATER SUPPLIES

Alvin Hamilton (Qu'Appelle): Mr. Speaker, I wonder whether the Minister of Agriculture would consider, in view of the fact that the rains of the last few days have missed such substantial areas of dried out southern Alberta, sending officials of P.F.R.A. to examine the supplies of water available to irrigate crops and see that supplies are stretched out as long as possible? In answer to his question, I can assure him that I am in close touch with the provincial government on the question of moisture in the province of Alberta. I have lived there all my life and farm 5,000 acres, so I do know a little bit about it. We have to watch the situation very closely. This is a provincial matter and they must take the initiative, but at such time as they do the federal government will be on hand.

Mr. Hamilton: A supplementary question. Would the minister, with his great concern for the people of that area, consider going himself and seeing how dry it really is?

Mr. Hays: In reply to this question, Mr. Speaker, I am leaving tomorrow morning at ten to seven.
