2. The establishment and terms of reference of the secretariat were announced in the [Mr. Schreyer.] House of Commons on May 12, 1964, by the then parliamentary secretary to the Prime Minister.

4. There are three officials specifically attached to the secretariat devoting from two thirds to three quarters of their time working directly for the secretariat. There are in addition a number of other officials in the Privy Council office who are concerned from time to time with the federal-provincial relation aspects of questions within their particular fields of responsibility.
