Mr. Andrew Brewin (Greenwood): A supplementary question. Can the minister say whether the same answer would be applicable to the requests of the municipalities in the maritime provinces that C.N.R. properties in those provinces pay full municipal taxes?

Mr. Pickersgill: Mr. Speaker, that is a matter for determination by the government.

However, I will put forward the hon. member's concern in future negotiations with Quebec regarding the matter of water.

I might add that we are now negotiating with Quebec on another water matter, and I will add this to the subject being discussed in the present conversations.
