QUEBEC-IMPRISONMENT AWAITING TRIAL-APPOINTMENT OF JUDGES

I might say that the daily administration of justice, the administration of the courts, is not directly a federal responsibility. As for the nomination of the judges, because I undertook to consult as widely as I could in judging the competence of men and women to be appointed to the bench, that consultation is still going forward. I hope there will be some appointments in the next two weeks or SO.
