### Order Paper Questions

The rates paid in nearby centres, such as Pacific Centre (700 Block Georgia) and Royal Centre (1000 Block West Georgia) vary from \$14 to \$22 per square foot per annum. (ii) There is no overpayment of rental fees to be estimated. The rate paid is competitive in consideration of the location, size, traffic flow and similar criteria.

2. (a) The market value of the property is estimated to be in the range of \$1,000,000 to \$1,300,000. (b) At the time preliminary investigations were being made to locate possible locations for the Information Canada facility, the owner of the subject building indicated the property was not for sale. Furthermore, future Crown construction would provide space for this operation.
