Has the minister made inquiries into the future status of the refinery at Come-By-Chance in Newfoundland and can he tell us whether, given the 400 jobs and the 100,000 barrels a day in output which are involved here, the government has any plans, through Petro-Can or whatever, to ensure the continued operation of this facility?

Hon. Alastair Gillespie (Minister of Energy, Mines and Resources): Mr. Speaker, I am aware of the difficulties at the Come-By-Chance refinery at the present time. I am also aware that Petro-Canada has made it their business to find out what is the problem. I cannot say more than that at the present time.

**Mr. MacKay:** Can the minister tell us what the effect will be on the supply situation in eastern Canada should this facility close?

Mr. Speaker: Order, please.
