I am wondering whether the minister can say if legal action or medical sequestration is being contemplated against this individual for the crime he committed against the Canadian law on Canadian territory overseas?

## PUBLIC SERVICE POST-RETIREMENT EMPLOYMENT ACT

MEASURE RESPECTING EMPLOYMENT OF SENIOR PUBLIC SERVANTS AFTER RETIREMENT

Mr. Walter Baker (Grenville-Carleton) moved for leave to introduce Bill C-434, respecting the conditions under which public servants may accept employment upon leaving the public service.

Some hon. Members: Explain.

Mr. Baker (Grenville-Carleton): Mr. Speaker, this bill ensures that retiring senior public servants are not able to take undue advantage of their former positions in obtaining new employment or acting as lobbyists. Guidelines are set forth to enable the governor in council to make the judgment as to when post-retirement employment of senior public servants with a particular firm or person is appropriate and when it is not.
