Order Paper Questions Establishment of Council

2. There is hereby established an advisory council to be called the Northern British Columbia Advisory Council, hereinafter referred to as "the Council".

Terms of Reference

- 3. The Council shall, in accordance with such rules of procedure as it from time to time establishes, assist the Minister responsible for the Northern Pipeline in carrying out the objects of the Northern Pipeline Act by giving advice and providing recommendations to him in all matters related to the Northern British Columbia portion of the Alaska Highway Pipeline, including:
- (a) advice on ways to minimize any adverse social and environmental effects of the project and to maximize social and economic benefits including employment opportunities from the construction, operation and maintenance of the pipeline; and,
- (b) advice on local and regional interests related to the pipeline and measures to facilitate effective consultation and communication with groups and communities affected by the pipeline.

Publication of Reports

4. In carrying out its activities within the terms of reference set out in Section 3, the Council may, from time to time, publish reports of recommendations in such manner as it deems appropriate.

Remuneration

- 5. (1) Subject to Subsections (2) and (3), each member of the Council shall be paid a fee of \$125 per day for each day spent in attendance of meetings of the Council.
- (2) The Chairman of the Council shall be paid a fee of \$175 per day for each day spent in attendance of meetings of the Council.
- (3) The Vice-Chairman of the Council shall be paid a fee of \$150 per day for each day spent in attendance of meetings of the Council.

DEFENCE INDUSTRY PRODUCTIVITY PROGRAM

Question No. 4,901—Mr. Sargeant:

Since the inception of the Defence Industry Productivity Program, which companies received assistance through the Program for the production of components for nuclear weapons systems and, in each case, how much assistance did the company receive and what components did it produce for which nuclear weapons system?
