

## CANADA'S ROLE IN COMMONWEALTH

**Mr. Howard McCurdy (Windsor-Walkerville):** Mr. Speaker, yesterday Bishop Tutu expressed utter contempt for the American action, which was cited as an example by the Prime Minister's colleague. Will the Prime Minister not accept the judgment of oppressed South Africans that tough sanctions are necessary, even if it requires their sacrifice, impose mandatory sanctions and go to the Commonwealth Conference to exert the kind of leadership that black South Africa expects?

**Right Hon. Joe Clark (Secretary of State for External Affairs):** Mr. Speaker, as the Right Hon. Prime Minister has indicated, I will be making another statement with respect to South Africa later this week. However, I simply wish to anticipate that somewhat to say that it is the view of this Government that one of the cards which Canada holds, which may have some influence on ending a totally unacceptable regime in South Africa, is, in fact, our membership and our influence in the Commonwealth. That involves a patient exercise of that influence, which is the way we intend to proceed.

However, I would like to continue by telling the Hon. Member that yesterday I had an opportunity to speak to Premier Buchanan of Nova Scotia on this subject. We have arranged to meet in the coming week to discuss, first, a report which is now in hand with respect to the alternatives with regard to Sysco. I think we will be able to make an announcement, as I say, even sooner.

## STATEMENT BY PRIME MINISTER DURING QUESTION PERIOD

**Right Hon. John N. Turner (Leader of the Opposition):** I rise on a question of privilege. Member had telephoned or sought information from law firms in Toronto, illustrates that the Prime Minister knew more about this issue than he let on to the House.
