##### CONSTRUCTION OF LINE TO GREAT SLAVE LAKE—REPORT OF COMMITTEE

Hayden,** Acting Chairman of the Standing Committee on Transportation and Communications, reported that the committee had considered Bill C-126, respecting the construction of a line of railway in the province of Alberta and in the Northwest Territories by Canadian National Railway Company from a point at or near Grimshaw, in the Province of Alberta, in a northerly direction to Great Slave Lake, in the Northwest Territories, and had directed that the bill be reported without amendment.
