SEARS A BIGAMIST.

Married to Wife No. 2 in Toronto Two Months Ago.

Rochester, N.Y., June 13.—George A. Sears, a consulting engineer for the Rochester Bridge Company, was arrested here today on a warrant sworn out by his wife, Dorothy, charging him with non-support. The fact developed that Sears was married two months ago to Georgia Hicks, at Toronto.

Mrs. Sears alleges that Sears has neglected her for over a year; that he sent her to Paris last fall, with only money enough to keep her a short time and not enough for her return. She threatened to appeal to the United States Consul at Paris, and the husband sent money for her return. He then paid her expenses at a hotel here. When officers went to the home of wife No. 2 today to arrest Sears he held them at bay at the point of a revolver. The officers were forced to besiege the place for twelve hours until Sears gave himself up. He was then released on bail. Mrs. Sears No. 1 came here from Brooklyn a week ago and secured the warrant. Sears has been living in this city with wife No. 2 since the marriage.

INTERRED ON DAY OF DEATH.

Abraham Crangle Rose in Good Health, Buried Ere Sundown.

Alive and apparently in good health yesterday morning; laid away in the grave for his last long sleep ere sundown. Such was the tragic termination of the career on earth of Abraham Crangle, sometime known as Goldstein. Crangle was a Hebrew, of considerable means, and has been living in the city for some time. He was in the store of D. Goldstein, a relative, at 245 West Queen-st., and Isaac Cohen, a clerk, was showing him a piece of cloth when he suddenly fell in a heap on the floor.
