Mr. Speaker: Order. Once again the hon. member seems to be attempting to make a comment during the course of the investigation. In any case, as I indicated to the House earlier, I have had the matter referred to me by the House. I took steps immediately following the disclosure by the hon. member for Central Nova (Mr. MacKay). After the completion of the parliamentary investigation under my authority, that is to say, by the security forces here in the House, I communicated those results to the hon. member for Central Nova. It seems to me he would not reasonably have been in a position to reply to that any earlier than yesterday. In fact, he replied to me this morning.

In any case it should be clear we are getting into very dangerous ground if we attempt to make comment during the course of the investigation. I prefer to conclude that investigation before entertaining any further comment.
