BINNEY, to be a Commissioner or Commissioners, or either of them, to tender and administer the usual State Oaths, according to Law, to all and every Person and Persons who is, are, or shall be elected, a Member of the House of Assembly in this Province; giving them, or either of them, full power and authority to perform the matters herein before mentioned, ratifying and confirming all and whatsoever the said Commissioners, or either of them, shall do and perform in this behalf.
