

Mr. Sinclair, the Hon. **Mr. Kelly**, **Mr. Sutherland**, **Mr. Doyle**, **Mr. Ramsay**, **Mr. Beer**, the Hon. **Mr. Gray**, **Mr. Montgomery** and **Mr. Cooper** do compose the said Committee.

Mr. Howat, from the Committee appointed to receive tenders for printing the debates of the House, for the present Session, presented to the House the report of the said Committee; which report was again read.

Ordered, That the said report be referred back to the Special Committee in order to amend the same.

Mr. Davies, from the Committee appointed to ascertain what progress has been made towards the completion of the Journals of the House for the last two Sessions, presented to the House the report of the said Committee,—which report being again read at the Clerk's table, was agreed to by the House, and is as followeth:—

Your Committee appointed to ascertain what progress has been made towards the completion of the Journals of the House for the last two Sessions, have to report, that having examined **Mr. William Malone**, contractor for printing the Journal for the Session of 1859, he stated that twenty-four copies of the Journal of that Session, bound and finished, would be laid on the table of the House, on Tuesday next, and the residue would also be ready for delivery at the end of next week.

Mr. James Barrett Cooper, contractor for printing the Journal of the Session of 1860, has handed in a few unbound copies of that Journal, containing part only of the Appendix, and states that owing to the scarcity of workmen he was unable to complete the work, but will do so as soon as possible, and in the meantime begs the indulgence of the House.

Your Committee recommend that tenders from the said parties, for the present Session, be not entertained, and also that in future no indulgence whatever be given to contractors.

Mr. Howat, from the Committee appointed to receive tenders for printing the debates of the House, for the present Ses-

sion, presented to the House the amended report of the said Committee,—which report was again read.

Ordered, That the said report be now committed to a Committee of the whole House.

The House accordingly resolved itself into the said Committee.

Mr. J. Yeo took the Chair of the Committee; and after some time spent therein,

Mr. Speaker resumed the Chair,

And **Mr. J. Yeo** reported that the Committee had gone through the report of the Special Committee, without making any amendment thereto; and the said report being again read at the Clerk's table, was agreed to by the House, and is as followeth:—

Your Committee, to whom it was deputed to receive tenders for printing the debates of the House agreeable to the Resolutions of the House yesterday, have to report that tenders have been received from the following parties, viz:—

First;—From **Mr. John Ings** offering to perform the work at the following rates: printing every sheet of four pages, the sum of Twenty-eight shillings; binding one shilling each copy.

Second:—From **Mr. John Ross** proposing to perform the work at Thirty shillings for each sheet of four pages, bound and unbound.

Third;—From **Mr. William Malone** undertaking to print the said debates at the rate of one pound seven shillings and sixpence per sheet of four pages, and one shilling each copy, for binding.

Fourth:—From **Mr. George T. Haszard** offering to perform the same at the rate of one pound seven shillings and six-pence, and binding the same, one shilling each copy.

Your Committee find that the tenders of **Mr. Malone** and **Mr. Haszard** are both alike as regards the rates: **Mr. Haszard's** being the most explicit, they recommend it to be accepted.

The Hon. **Mr. Haviland** from the Committee appointed to receive tenders for printing the Journal of this House, for the present Session, presented to the House the report of the said Committee, which report was again read.
