Two classes of lawyers practise law in Japan: those admitted to practise in Japan and appear before Japanese courts, and the gaikokuho-jimu-bengoshi-jimusho, or foreign legal consultants resident in Japan. The foreign legal consultants are a relatively recent phenomenon. Although they are not authorized to appear before Japanese courts or to act as Japanese attorneys, they can act on behalf of foreign nationals in connection with licensing and joint venture matters in Japan. Their familiarity with Japanese

practice, combined with their Western training, can be very helpful to other Westerners working in Japan.

To find the names of foreign lawyers in Japan, or Japanese law firms that employ foreign nationals, you may want to consult the Martindale Hubbell Law Directory, Volume VI, international lawyers, and Martindale Hubbell Prestigious Lawyers, a one-volume work which lists U.S. and foreign lawyers by country, naming the top law firms practising in those countries, their areas of practice, clients, and the names and qualifications of the partners. Most law associations have these directories, as would any university with a law faculty.

## **STATUTES**

The Canadian statutes relating to intellectual property are the Patent Act, the Copyright Act, the Trade-marks Act, the Industrial Design Act, and the Plant Breeders' Rights Act. Copies are available from any bookstore that sells federal government publications or from the address listed below. In addition, an act that would address integrated circuit topography is currently under consideration.
