Returns and Reports Deposited with the Clerk of the House

By Mr. Halpenny, a Member of the Queen's Privy Council,—Return to an Order of the House dated October 15, 1962, (**Question No. 136*) showing: What has been the total storage cost for butter oil and/or butter stock in (a) 1958 (b) 1959 (c) 1960 (d) 1961 (e) 1962?

By Mr. Halpenny,—Return to an Order of the House dated October 15, 1962, (*Question No. 174*) showing: 1. In connection with the import of fruits and vegetables from the United States into British Columbia, what volume in millions of pounds of the following produce was imported during 1961 and to date in 1962: (a) apples (fresh) (b) peaches (fresh) (c) tomatoes (fresh) (d) strawberries (fresh) (e) carrots (f) onions (g) potatoes (h) tomatoes (canned)?

2. How many processing and canning plants in the Okanagan area of British Columbia in the past ten years have been bought out by United States firms and closed down?

By Mr. Halpenny,—Return to an Order of the House dated October 17, 1962, (*Question No. 188*) showing: 1. What is the quantity of butter held in storage at the present time?

2. Where are storage warehouses located, what quantity is there in each warehouse, and what is the monthly rental and other cost for each such warehouse?

3. Has a large quantity of butter been transformed into butter oil and, if so, how does the government intend to dispose of it?

By Mr. Halpenny,—Return to an Order of the House dated October 15, 1962, (*Question No. 232*) showing: During the first nine months of the years 1961 and 1962 (a) what has been the production of butter in Canada (b) what has been the consumption of butter (c) what amount of premium has the government paid on the said consumption?
