## COMMITTEES-PERSONNEL

Right Hon. W. L. MACKENZIE KING (Prime Minister) moved:

That the name of Sir Henry Drayton be substituted for that of Mr. Young (Toronto North-east) on the select committee on standing orders, and that the name of Mr. Young (Toronto Northeast) be substituted for that of Sir Henry Drayton on the select standing committee on railways, canals and telegraph lines.

Motion agreed to.

## TRADE MARK AND DESIGN ACT AMENDMENT

Hon. PETER HEENAN (Minister of Labour) moved for leave to introduce Bill No. 171, to amend the Trade Mark and Design Act.

Mr. GUTHRIE. Explain.

Mr. HEENAN: The purpose of this bill is to give permission to the labour unions of Canada to register their labels and to prevent the use of forgeries or counterfeits. While giving the right to unions to register labels, the bill provides that no label can be placed on any goods without the consent of the proprietor of such goods. A similar protection is given to the labour unions in many states of the union and in Great Britain.

Motion agreed to and bill read the first time.
