Mr. Fulton: I will make one more endeavour to reason with Your Honour. I wish to be heard on the point of order. You may say that the minister has moved a question but I wish to be heard on a point of order before the question is put. Your Honour should permit me to put the point of order before the question is put. The point of order is this—

The Chairman: Order. I indicated that I was bound by the terms of the standing order and that I proposed to put the second question. I can do nothing else if the hon. member—

Mr. Fulton: May I point out to Your Honour-

An hon. Member: Sit down.

Mr. Fulton: It has been permitted on previous occasions-

The Chairman: I ask the hon. member to resume his seat. If the hon. member does not do so I must report to Mr. Speaker.

The Chairman: Order. I am reducing the question to writing in order to report to Mr. Speaker.

Mr. Knowles: Mr. Chairman-

Some hon. Members: Order.

The Chairman: I am in the course of reporting this matter to Mr. Speaker and until that is done I have no further—

Mr. Knowles: Mr. Chairman, this-

An hon. Member: Sit down.

Mr. Knowles: Mr. Chairman, this afternoon-

An hon. Member: Sit down.

Mr. Knowles: Mr. Chairman, this afternoon when you were—

Some hon. Members: Order.

The Chairman: Order.

Mr. Knowles: Mr. Chairman, this afternoon when you were at this same stage you accepted advice from the Minister of Finance. Why is it you accept advice from the Minister of Finance and you will not accept advice from this side?

An hon. Member: The majority are on this side.

An hon. Member: The majority rules.

The Chairman: Order.

And Mr. Speaker having resumed the chair:

Mr. Robinson (Simcoe East): Mr. Speaker, in committee of the whole when considering the resolution with respect to Northern Ontario Pipe Line Crown Corporation Mr. Fulton attempted to raise a point of order and I ruled that in accordance with the provisions of standing order 33 no member shall rise after one o'clock a.m. I directed the hon. member to resume his seat; I did so after putting the question with regard to concurrence in the resolution and immediately prior to attempting to put the question that I do leave the chair, and the hon. member declined to do so.

An hon. Member: He rose on a point of order.
