## POLLUTION

LAKE SIMCOE—GOVERNMENT ACTION TO PREVENT FURTHER POLLUTION BY PHOSPHOROUS

Mr. P. B. Rynard (Simcoe North): Mr. Speaker, I wish to direct my question to the Minister of the Environment. In view of the fact that the Department of Agriculture has recently released a report indicating that phosphorous has become a major pollutant in Lake Simcoe, may I ask what action is being contemplated by the Department of the Environment to prevent further pollution of this lake and, in particular, of the Holland Marsh area?

Hon. Jack Davis (Minister of the Environment): Mr. Speaker, Environment Canada is working closely with the Department of the Environment for Ontario in an attempt to solve the problem. We have, ourselves, taken action with respect to detergents. The research facilities of the Canadian Center for Inland Waters are also involved. This is a co-operative federal-provincial program.
