LOSSES SUFFERED BY ATLANTIC AREA FISHERMEN FROM STORM—SUGGESTED SPECIAL FEDERAL ASSISTANCE PROGRAM

Mr. Thomas S. Barnett (Comox-Alberni): Mr. Speaker, my question to the Minister of Fisheries arises from representations I have received and which the minister has indicated he has received about the storm that seriously affected the fishermen of Prince Edward Island, Nova Scotia and apparently Newfoundland. In light of the discussion we have had, is he prepared to recognize that, fisheries being under federal jurisdiction, a special program of assistance should be undertaken to assist those fishermen at his initiative?

Hon. Jack Davis (Minister of Fisheries): Mr. Speaker, as the hon. member may recall, a special program of the nature of insurance for gear was instituted a few years ago. The fishermen, however, did not see fit to pay the premiums, and so we are back to the usual argument as to who pays for damage after a loss has occurred.

ADMINISTRATION OF JUSTICE

SUGGESTED AMENDMENT OF CRIMINAL CODE TO INSTITUTE CORPORAL PUNISHMENT FOR CERTAIN CRIMES—GOVERNMENT POSITION

Mr. Dan Hollands (Pembina): Mr. Speaker, my question is for the Minister of Justice. It deals with the brutal rape and robbery of a 70-year old woman in Edmonton last week. Since these subhuman acts are on the increase, will the minister consider bringing in amendments to the Criminal Code to institute some form of corporal punishment for such crimes as a deterrent to this type of criminal?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, notwithstanding our abhorrence of this kind of activity it is still our position, as it was the position of a very large majority in the House several years ago, that corporal punishment in our penal institutions is not a desirable remedy.

Some hon. Members: Hear, hear!
