to keep food prices to the consumer from continuing to escalate.

Hon. Mitchell Sharp (Acting Prime Minister): Mr. Speaker, there will be proposals put before the conference of that kind, but not only at this particular conference, of course. The Minister of Agriculture himself has emphasized on a number of occasions that this is one of the main purposes of policies now being proposed by the government to deal with the inflationary problem.

POSSIBILITY OF A PRICE SUPPORT PROGRAM—GOVERNMENT POSITION

Mr. David Lewis (York South): Mr. Speaker, may I ask the Acting Prime Minister or the Minister of Agriculture, whichever one of them feels he can deal with the question, whether the government will propose a program of price support for agricultural products so that the farmer may be able to plan ahead and to increase the supply of food products but at the same time be guaranteed a reasonable and decent income, taking into account his costs of production.

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, the only thing I can say about what I will say at the conference is this: my approach would be—concrete perhaps is not the right word to use—solid. It would be a solid approach to agricultural production that would mean benefits not only to the agricultural producer, but for the consumer in Canada, for consumers in the world and for customers we have built up by export sales largely for our agricultural products.

Mr. Speaker: The Chair will recognize the hon. member for York South on a supplementary and then, as I said a moment ago, the hon. member for Témiscamingue.

POSSIBLE ESTABLISHMENT OF PROVINCIAL BANKS UNDER PUBLIC OWNERSHIP—GOVERNMENT POSITION

Mr. David Lewis (York South): Mr. Speaker, perhaps some day I will learn the difference between concrete and solid. I should like to turn to another subject to be dealt with at the western conference and ask the Acting Prime Minister or the Minister of Finance, whichever one of them wishes to answer, whether the federal government will be ready to agree to an amendment to the Bank Act in order to make it possible for provinces to establish provincial banks under public ownership, if the provinces so desire

Hon. John N. Turner (Minister of Finance): Mr. Speaker, that is one of the options I suppose that is open to the federal government, and any reaction to that proposal would be made at the conference itself.
