Mr. Stanfield: Mr. Speaker, I have ascertained what I wish to know. I have confirmed that there are no powers until an emergency is declared, and the minister is not prepared to say that this state exists today.

Some hon. Members: Hear, hear!

## LABOUR RELATIONS

ONTARIO BILL RESPECTING SCHOOLTEACHERS— FEDERAL GOVERNMENT POSITION

Mr. Derek Blackburn (Brant): Mr. Speaker, my question relates to the question I asked the Minister of Justice on Monday. As Bill 274 has now passed second reading in the Ontario legislature and as sections of the bill are contrary to civil liberties, to be precise, forced labour, is the minister now in a position to recommend the disallowance of this provincial legislation?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, the question is clearly in its terms hypothetical since disallowance can hardly apply at this stage. It is the general position of the government that the power of disallowance is a rather extraordinary one to be used in special circumstances. The ordinary remedy for dealing with laws of the provinces lies in the political processes in the provinces.

Mr. Blackburn: Has the minister been in contact with his provincial counterpart with respect to the legality of Bill 274?

Mr. Lang: No, Mr. Speaker.
