VENICE SUMMIT—COMMITMENTS ON INCREASED USE OF COAL—ACID RAIN

Mr. Doug Frith (Sudbury): Madam Speaker, my question is directed to the Minister of Energy, Mines and Resources. The Summit conference in Venice during last weekend resulted in a commitment by the participating countries to increase their coal production, using coal as an energy resource in order to reduce their energy consumption of oil.

What commitments were made by the participating countries which will ensure that the increased use of coal will not aggravate the acid rain problem?

Hon. Marc Lalonde (Minister of Energy, Mines and Resources): Madam Speaker, at the Summit in Venice all heads of states recognized the importance of increasing very substantially the production of coal over the next decade if we are to meet the needs of the industrialized world.

The Prime Minister and the Canadian delegation insisted very strongly upon the necessity of making sure that the environmental concerns be respected and that all necessary steps be taken to protect the environment. There was a special reference to this subject included in the final communiqué of the conference.

I am also happy to report that my colleague, the Minister of the Environment, has been in extensive consultations with his American counterpart over the past few weeks on the whole issue of acid rain. If the hon, member wishes to ask the minister about his discussions, I am sure he would be very happy to inform the House of developments in this regard.

MARITIME AGENCIES LTD., VANCOUVER—DEBTS OWED BY GOVERNMENT

Hon. J.-J. Blais (Minister of Supply and Services): Madam Speaker, I am not in a position at this time to furnish any further information relating to MAL. I would be pleased to discuss the matter with the hon. gentleman.

I have been in touch with the Minister of Industry, Trade and Commerce and the Minister of Justice to hasten a resolu-
