Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I cannot confirm any ongoing negotiations. As my hon. friend would know, having served in high government office, questions of this magnitude are negotiated and dealt with, with various proposals on the table. I do not think he would really expect me to confirm or deny whether there are any ongoing negotiations.

Hon. Herb Gray (Windsor West): Mr. Speaker, I have a supplementary question for the Prime Minister. If the reports are correct, and they are apparently based on a visit paid recently by the Minister of Regional Industrial Expansion to the Premier of Bavaria, Mr. Strauss, the chairman of Airbus Industrie, I would like the Prime Minister to explain why the Government is not willing to keep Canadair and de Havilland, the technology they developed, and the jobs they provide under Canadian public ownership, but instead is willing to sell them to Messerschmitt of Germany, a company that has a substantial degree of state ownership, or to Airbus Industrie, a consortium of European companies, most or all of which are also publicly owned?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I do not know why my hon. friend would jump to the conclusion that he has, and assert that as a matter of fact when it is no such thing. In his first question he referred to it as an allegation in *The Globe and Mail*. In his second question, it is a statement of fact that the Government is confirming its intention to do so. There have been no such transactions concluded. Negotiations continue with a number of interested parties, Canadian, North American, and European. At an appropriate time, when the Minister returns and a proper evaluation has been made and submitted to Cabinet, we will be delighted to inform the Hon. Member and the House.

Mr. Gray (Windsor West): CDIC has confirmed these discussions are under way—his own Crown corporation.

Mr. Mulroney: Not our own Crown corporation; your Crown corporation.
