Mr. Mulroney: Obviously the Public Affairs Department of the Embassy is doing its job extremely well.

Mr. Turner (Vancouver Quadra): Trying to keep its job.

Mr. Mulroney: I would like to give a little more guidance if I could, but I will listen to my right hon. friend complain.

With regard to the question he raised about acid rain, we have a commitment from the President of the United States speaking on behalf of his administration which, in our judgment, is satisfactory. We believe the administration is working toward those objectives. We will have an opportunity to judge for ourselves, as we all ought to, at an appropriate time.
