- (b) The permanent staff, both military and civilian, for all three organizations will number 130 personnel. (Note that 67 personnel with the naval reserve headquarters have been located at 94 Dalhousie since 1988).
- (c) The naval reserve facility will consist of three buildings:
- (1) A new quarters building will be built on Dalhousie Street to house the residence and the messes:
- (2) The existing Hanger 19 will be extended and renovated as the Training building and will house HMCS Montcalm and the Canadian Forces Fleet School Quebec training resources; and
- (3) The John Munn building at 112 Dalhousie Street will be renovated as office space for CFFSQ and NAVRES HQ administration offices.
- (d) The projected recurring maintenance and operating costs of the three buildings are estimated at \$2,269,000 a year, including \$533,000 for equipment operating costs and \$1,736,000 for facilities/services (budget year 1996–97).

Through the Chair perhaps I may say to the hon. member that the member he is referring to can and will be made available tomorrow morning. Perhaps at that time the hon. member would want to raise his substantive point at that time. I think there has been some difficulty with respect to transportation to and from the constituency. If the hon. member would care to wait, the hon. member could be here tomorrow and I am sure the matter could be argued in its complete context.

Mr. MacDougall: Mr. Speaker, I am prepared to wait but I would like to comment that it has been a very difficult four days for myself and my family and for my constituents when allegations like this are made.

An hon. member: Well, go ahead.

Mr. MacDougall: I would like to ensure that the member is here so that she can really deal first hand with what she has said and the difficulty it has caused for me and my family.

Mr. Dingwall: Mr. Speaker, I believe we can give the undertaking that the hon. member will be here tomorrow to debate and add her particular intervention to the suggestion made by the hon. member.
