### Roche, W. J. (Marquette)-760.

# Sproule, T. S. (East Grey)-751.

Asks the difference between a provincial land surveyor before 1872, and one who

has qualified since—755.
On section 42—Was it not decided that they would have to buy the road allowance in every instance where they departed from the regular survey—761-2. That would seem to be an amendment to the constitution—763. Under this the surveyor may make a change whether a man has or has not a right to the land -764.

## Thompson, A. (Yukon)-757.
