Question No. 2,987—Mr. Epp:

1. Under the Special ARDA Program entered into under agreement between the government and the Province of Manitoba, what amounts of federal moneys were granted to Mr. Laubman at Pikwitoei, Manitoba?

Mr. Ed. Lumley (Parliamentary Secretary to Minister of Regional Economic Expansion): The reply for the Department of Regional Economic Expansion is as follows: 1. Under the Special ARDA Program, to July 31, 1977, \$14,800.72 of federal moneys were expended to assist Percy Laubman.

2. Financial assistance was committed on August 8, 1972 under Section 1(e) of the Canada/Manitoba Special Rural Development Agreement, dated July 20, 1971, as follows: "The establishment, expansion or modernization of any commercial undertaking engaged in the utilization of primary resources, in processing, in manufacturing or in the provision of services, including tourist facilities, provided that (i) the undertaking is expressly organized so that at least two-thirds of those employed are disadvantaged people who have previously had little or no access to regular earning and employment opportunities; and (ii) there is adequate provision for such counselling, training and other adjustment measures as are necessary to the employment of disadvantaged people in the undertaking."
