

Tabusintac Light :--"The fixed red light at Tabusintac is situated on Crab Island at the mouth of the Tabusintac River and has a white light erected on a pole at a distance of one hundred and filty feet in front to range with it, and has always given satisfaction. In the fall of 1870, on the occasion of a severe storm, a new gully was opened up. This has not in any way interfered with the usefulness of these lights, and the light keeper states that the position of the lights should not be changed at present.
