WOODSTOCK HOSPITAL HAS DEFICIT FOR YEAR

Report at Annual Meeting Last Night Shows Indebtedness of \$1,248—Over Two Hundred Patients Treated.

Woodstock, N. B., June 24.—The annual meeting of the directors of the Fisher Memorial Hospital was held in the town hall tonight, J. T. A. Diblee presiding. This institution is governed by seven trustees of which Rev. J. J. McMurray is chairman. The Fisher estate appoints four trustees and the directors elect three.

At this meeting the former members, Col. P. H. J. Diblee, W. B. Bell and John Connor were re-elected. The expenditure for the past year was \$7,982.06, the receipts \$6,735.36, leaving a deficit of \$1,248. There were 204 patients treated during the year as against 188 last year; 42 were free patients as against 45 last year. The mortality cases were very few as compared with other hospitals.

There were many patients from Victoria County as from Carleton County, and a greater number of free patients from Victoria County although the hospital is in receipt of a grant from that county. At a big field day which will be held here next week, it is hoped to raise sufficient funds to wipe out the indebtedness.
