MR. INNES EXTRA BESSIONAL INDEMN Tr.-Mr. Innes has distributed his extra sessional indémnity, passed last session of Parliament, as follows:— 50 each to the Erin, Eramosa, Guelph Township and Puslinch Agricultural Societies. Along with these grants is made the suggestion that the Directors of these societies should, if they think well of it, apply the money in one, or two or three prizes for the best kept, best cultivated and most improved farms in each Township. If the Direc tors of any of the societies are of opinion that this proposal cannot well be carried out, they are at liberty to use the money in any way they think best for the good of their societies, and in the interests of agriculture in their respective Townships. In the case of the Guelph Township Agricultural Society, if the Directors do not apply the money in the way indicated, they are empowered to hand it over to the outh Wellington Agricultural Society. He also grants \$100 to the Free Public Library, for the purpose of forming the nucleus of a Museum in connection with it if the Directors so determine. and if not they are empowered to spend the money in any other way they think best for the good of the Institution. Also \$50 to the Guelph General Hospital, \$50 to St. Joseph's Hospital, and \$50 to the City Benevolent Fund, under the charge of the Chairman of the Council's Relief Com-

Some people have very mistaken ideas about the Scott Act, or how it affects the public at large. It was, we think, one speaker at the municipal nominations who talked about his candidate for Mayor seeing fair play done for the hotel keepers and all other classes in the city. Why, after the Scott Act comes in force all are put on the same level as regards liquor selling. The person who keeps a public house will have no more right to sell liquor than any other resident in the municipality. The law prohibits every one, unless the duly licensed druggist from selling liquor of any kind. How then can any Mayor or Alderman, or any civic functionary whatever, see fair play to any hotel keeper or any one else for that matter in the matter of selling liquor? The whole thing is narrowed down to the simple point that if any one sells liquor contrary to the law, and the fact is proved, he will be fined. 'If he does not sell of course he does not come in within the pale or grasp of the law, but to talk about fair play in such a case is absurd.
