Fire and Water Committee Has a Busy, Hot, Night Session-Union Teamsters Want None But Members of Their Union Employed on Street Watering.

Chairman Dixon. and Ald. Hobson, Hurd. Dunn and McFadden spent over two hours on Fire and Water business last night, and didn't lose any time either. A feature of the meeting was an informal discussion about the duties of Storeskeeper Wm. McAndrew, brought on by Ald. Dunn and participated in by Mr. McAndrew and the members generally. It showed that under the new arrangement things are not as harmonious as they might be.

Messrs. D'Arcy Martin and J. L. Counsell, on behalf of the Hamilton Cricket Club, asked that permission be given the club to water the grounds in other hours than those specified. Mr. Martin pointed out that the water is used only three months, and is not a lawn, a boulevard or a garden, and therefore does not come under the city by-law. The matter was referred to a sub-committee to report.

Ald. Evans made a similar request on behalf of the Court House square, but the committee seemed to think that if more watering was needed there, it would be easy to put in more taps and get more hose.

Two or three petitions were received against the watering of as many isolated blocks of city streets. Superintendent McAndrew put in a protest against any blocks being exempt from the watering rule. When there was an odd block not watered the people yet the benefit of the watering around, while those who pay for watering have to put up with the dust of those who do not pay. Hamilton, he said, is practically watered from Wentworth street to Victoria Park and from the mountain to the bay, and there should be no exceptions. The committee decided that it had no power except to stop watering where it was petitioned against.

Want Only Union Teamsters.

Quite a large number of city teamsters were present to ask that none but members of the Teamsters' Union be given work on street watering. Opposed to them were a number of horse owners, who are not members of their union and whom the union will not admit as members because they do not own wagons, but simply are horse owners, but whose horses are engaged in street watering.

Chairman Dixon stated that he had seen Mr. Dunning, Secretary of the union recognized, the regular teamsters would not press for the dismissel of non-union men this season, but would start on a strictly union basis next year.

Residents on James street, north of the G. T. R., sent in a largely signed protest against the sprinkling of the street. The electric sprinkler, they said, makes such a cloud of dust that they would prefer that the street be not watered at all.

Superlutendent McAndrew informed the committee that in his opinion the condition of the street is the cause of the trouble. There is so much dirt on the streets, and the electric car runs at such a speed that a cloud of dust is created. This was particularly the case on Barton street, where tar macadam road, without curbing, was laid, and the boulevards have become trodden all over the road. The street sprinkler, he said, works 12 hours a day, and has to do 47 miles of watering. If the car is run any slower, he said, the work cannot be done.

The suggestion was made that James street, below the bridge, should be watered by carts. Chairman Dixon, Ald. McFadden and Dwyer, Manager Barrow and Superintendent McAndrew were authorized to consult with Traffic Manager Green, and see if any improvement can be made in the system.

Privates T. E. Patteson (of MacLeod), J. F. Moreller (Pincher Creek), and Kerr were killed, Lieut. W. M. Inglis (late Berkshire Regiment), Pte. T. R. Miles (Pincher Creek), and Pte. A. Aspinall, N. The guns were defended stiffly by the enemy, and when defeat stared the Boers in the face they hid the guns in a native kraal, prior to their disappearing in the night. There the guns were found by the Canadians and brought to camp, an exploit which Lord Roberts recognizes by a special mention in general orders to day.

While at Rustfontein the Mounted Rifles joined hands, much to their delight, with C Battery, which was present at the relief of Mafeking, and afterwards marched across country under Major-General Baden-Powell.

London, June 27.—A Pretoria despatch dated yesterday says: A supplement to the Official Gazette of yesterday gives warning that no person will be allowed to reside in any town for six miles above and sixteen miles for six miles above and sixteen miles below Pretoria, unless possessed of a police pass, which will be granted only to those who, not being British sub-jects, take the oath of allegiance and surrender their arms. There has been a notable increase in the number of civilians in Pretoria since last Sunday. There, was the largest marks, today civilians in Pretoria since last Sunday. There was the largest market to-day since the entry of the British troops. The market square this morning was two-thirds filled with farm wagons, and there were eighteen spans of oxen, the owners of whech were selling produce. The railway from Pretoria to Vereeniging is now running and a regular time table has been issued. The railway is available for civilians who hold a written railway permit. No news relating to the outside world has been published here since the entry of the British.

Eloff at St. Helena.

Jamestown, St. Helena, Jame 27.—
Sarel Eloff, President Kruger's grandson, who was captured by the British at Mafeking, landed here to-day with eleven officers and 98 troopers, mostly foreigners. The prisoners, who were clean and of respectable appearance, were immediately sent on to beadwood, the prison camp. Most of the Boers at Deadwood are in good health, and thus far there has been but one death from enteric fever. Eloff at St. Helena.

KINGSTON SMELTER BY-LAW Bonus of \$33,000 and Free Site

Bonus of \$33,000 and Free Site Overwhelmingly Carried.

Kingston, Ont., June 27.—The smelter by-law submitted to-day was carried by 1,110 to 64. It grants \$4,000 per year for 15 years. The bonus in money means only a practical outlay from the people of about \$33,000, besides \$10,000 for the site. In exchange for this, the Cataraqui Smelting and Developing Company will build works costing over \$300,000, will employ 100 men to smelt at the start 200 tons of ore daily, which quantity will be largely increased before many mouths, with a greater force of workers. Building will be commenced this year, and work will be in operation before the end of next year.


