LOCAL AND OTHER ITEMS.

The estate of the late Timothy Eaton, Toronto, has paid to the succession duties department on account \$100,000.

Rev. Father Ryan of St. Paul is visiting his native Province. He sang the high Mass in the Cathedral on Sunday last.

The new railway station at Charlottetown, was opened for business on Monday of this week. The outgoing trains left from the old station; but the incoming trains arrived at the new station.

The cheese board met yesterday afternoon. There was not a very large attendance, and the quantity of cheese produced was not much larger than at the first meeting. The highest price offered was 11 1/2 cts, at which nearly all was sold.

Eugene Schmidt, ex-Mayor of San Francisco was sentenced to five years in the penitentiary, on Monday last. The indictment on which he was sentenced was for extorting money from keepers of French restaurants. He is still subject to trial under indictment for reception of bribes.

The capture of General McLean, Commander of the Baltic's bodyguard by Russell was reported to the British Legation in this city. The British Legation was directly to the authorities at P. E. when General McLean was captured. Russell ordered him to dismount from his horse and mount a mule in order to show his inferior station.

The Government steamer Montcalm, went ashore on North Bar near the entrance to North Sydney Harbor, on Wednesday night last, as she was returning from the C. P. R. Steamer Empress of Ireland. She was floated early Friday morning when the tide was highest. Three powerful tugs were called into service. It is thought the steamer is not injured.

The Allans instructed their agent at North Sydney to cancel all bookings from that port by the steamship Virginia due there this Sunday. This has proved very disappointing, and it is considered the grounding of the Montcalm has been used as a pretext for discontinuing the call at that port. Some forty people had to go to Rimouski, to connect with the Virginia.

The storm of yesterday afternoon was most violent in this city. Terrific thunder, dazzling lightning accompanied by a fierce downpour of rain and some heavy hail constituted as wild a storm as has visited Charlottetown for many a day. No serious damage has been reported. It is said some fifteen telephone posts in the vicinity of Clyde River, were completely destroyed.

While the Ward Line steamer Monterey was being inspected by the health officer at New York, last Friday night her cargo of 300 bales of hemp caught fire. The steamer's fire fighting apparatus was got into action and the steamer started and was beached at Clinton Island. The fire was got under control in two hours. The Monterey had arrived from Havana with a quantity of sugar beside hemp.

Two of the big trolley cars of the International Railway Co. Lockport Line, collided head on near Tonawanda, N. Y., last Friday night, when going at the rate of fifteen miles an hour. The vestibules were smashed, but the cars stood on the tracks. One motorman was crushed to death and a conductor was fatally injured, and a motorman and conductor were injured. Almost all the thirty passengers were more or less injured.

It is believed that at least ten lives were lost in the storms which swept West Virginia on Wednesday night of last week. Many persons were injured and much damage to farm property and dwelling houses is reported. According to reports received here Quebec, on the C. M. & St. Paul Railway, near Camp Douglas is wiped out and four persons were killed there. At Grand Rapids, Wis., five are killed. Communication has not yet been well established with that place.

LOCAL AND OTHER ITEMS.

Thirty-seven persons dead and two thousand one hundred and fifty three maimed, is the result reported from Chicago, of the fourth of July celebrations in the United States.

A severe thunder storm passed over the town of Mahone Bay, yesterday morning. The spite of the Anglied; shing was struck by lightning and sustained damages to the extent of one thousand dollars. A yacht was also struck and had a hole punched through both sides.

In the second trial, at Hopedale, C. P. N., of Collins for the murder of Mary Ann McAuley, the jury disagreed and were discharged. The charge of Chief Justice Tuck was strong against the prisoner and the chain of circumstantial evidence was very strong; yet the jury could not agree on a verdict. The court adjourned to September 17th when Collins will likely be tried again.

Summerside appears to have a visitation of smallpox of the same mild type as that which we had in Charlottetown last winter. A few people have been slightly ill, and at present three persons supposed to have small pox are quarantined in their homes. All necessary precautions to prevent the spread of the disease seem to be taken.

The Dominion Iron and Steel Company's pier at Bellefleur mine, Conception Bay fifteen miles from St. John's Nfld. was destroyed by fire on Friday last. The loss is \$50,000 and the insurance half that amount. The pier was an immense wooden structure and was filled with machinery together with 5,000 tons of coal. The machinery and ore fell into the bay. Eight hundred men fought the flames for hours; but the fire burned brightly in the coal. The loss will cut off shipments of ore to Cape Breton furnaces. Four hundred tons of ore were shipped to Sydney last year.
