MANY INJURED IN RAILWAY CRASH

Missouri Pacific and Santa Fe Trains in Collision.

Kansas City, Mo., Sept. 21.—J. H. Durham, a fireman, was killed, and a score of persons were injured in a railroad collision between a Missouri Pacific and a Santa Fe passenger train at Sheffield, 10 miles east of Kansas City, early today. It is believed that none of the injured will die.

Nearly all of the mail clerks on the Missouri Pacific train were bruised and cut, two of them being injured seriously.

Both trains enter Kansas City over the same tracks. The Santa Fe train stopped at a crossing, and the other train crashed into it.

GATES WON'T STARVE

Reamont, Texas, Sept. 21.—John W. Gates' will, which was made last March and modified by a codicil made in May, was filed for probate here today, and was for the first time visible to the public.

It is definitely known for the first time that instead of leaving the great bulk of his estate to his son, Charles G. Gates, as had been reported widely, John W. Gates made his widow, Mrs. Isadora R. Gates, residuary legatee. But it is declared that Mr. Gates, pursuant to her husband's wish, expressed to her during his last illness, will turn over to her son a portion of the estate bequeathed to her, sufficiently large to make their shares approximately equal. The authority for this statement has not been made public.

The application for probate states that the estate will amount to more than \$5,000,000. James L. Autrey, of Houston, who filed the application, said this amount had been fixed as a mere formality. The estate's value has been estimated at from \$5,000,000 to \$20,000,000. Wall street made the lowest estimate.

Mrs. Gates and Charles G. Gates, wife and son, are named as executrix and executor without bond.

To Charles G. Gates is willed \$1,000,000 outright, and an annual income of \$100,000, derived from a trust to be established for his benefit which amounts to about \$2,000,000. The trust is to continue during his life, so that, whatever happens in his business transactions, Charles G. Gates cannot "go broke."

The will provides for the payment of a balance of a donation which Mr. Gates made to the Methodist Episcopal board of education, and bequeaths \$100,000 to the Arthur A. Heustler fund of the Gates Old People's Home at West Chicago, Ill., was revoked by the codicil.

Bequests to relatives and friends and servants, amounting all told to about \$700,000, are made as has been previously published.

PRESS CENSOR STOPS ALL CHOLERA NEWS

Officially the Plague Does Not Exist in Italy.

London, Sept. 21.—Italy may be said to have been fairly successful in her efforts to suppress the false concealing the epidemic of cholera, though occasional pieces of news on the subject do reach the outside world.

Naturally enough, as officially cholera does not exist in Italy, the press censor stops every telegram alluding even remotely to a contagious disease. The local newspapers abstain from publishing information about cholera, and to all intents and purposes public health in Italy is excellent.

Reports circulate that cholera is raging in many towns and villages in Southern Italy, especially in Calabria and Sicily, but such reports are invariably denied and attributed to the desire of foreign tourists to come to Italy, or to clericals who want to spoil the patriotic celebrations of the year.

The Cholera Riots.
The cholera riots at Verbarico, naturally being of the kind which the government, but only a few newspapers attributed them to cholera. The Corriere della Sera, of Milan, sent a reporter to the scene, and he reported fully the situation, but naturally enough the press censor did not allow any news to be transmitted about the riots. The reporter says the correspondent, like those of all the villages in Calabria and Sicily, of those who died from cholera, is a disease that is propagated by the Government officials, police, doctors and mayors. They consider cholera one of the many drawbacks of a civilized government, and they are fully convinced that people die because they follow the instructions of the Government. Naturally enough, as prophylactic measures are opposed and often evaded, the epidemic spreads with great rapidity, and the death toll is very high. The villagers were then still more convinced that they were being murdered, and they rose to defend their lives. They had to kill the mayor and the Carabinieri, but succeeded in murdering the deputy town clerk and frightening to death a magistrate.

Verbarico is now occupied by soldiers, and out of its 4,000 inhabitants only 100 remain. In the villages the rest are hiding in the woods, armed with hatchets and knives, ready to kill the soldiers and police. The bodies of those who died from cholera were until a few days ago left unburied in the village, and as many are dying daily, their bodies, too, are naturally left unburied.

Verbarico is a village on the top of a mountain, without water and surrounded by a high wall. There are no roads leading to it, but only a few paths. There are hundreds of bodies lying about the village, and the bodies of those who died from cholera are being used by revolutionary agents to further a campaign of violence against the state.

DAVE DISCHLER DIES POOR MAN

Once Rich Politician and Sport Mixed Up in 'Bunco' O'Brien's Jail Break.

Utica, N. Y., Sept. 21.—David A. Dischler, well known in this day as a politician, a sporting man, and one who has been mixed up in various schemes, died at his home in this city following an operation for appendicitis. He was 57 years old.

At one time Dave Dischler occupied national attention. That was in 1912 when Tom (Bunco) O'Brien escaped from the city of Utica, and Dischler was one of the many persons who were concerned.

O'Brien was brought from the prison to Utica on a horse-drawn cart, and through the assistance of a woman, a prison keeper who had charge of O'Brien, he was spirited away by a horse-drawn cart.

Dischler was charged with conspiracy in the escape, but he was not found guilty. He was never recaptured by state authorities, and he died in a foreign prison after various adventures.

HORNE AT MONTREAL

Clerical Member of British Commons Makes Several Addresses.

Montreal, Sept. 20.—A complimentary luncheon was tendered today at the Presbyterian College to the Rev. Sylvester Horne, the clerical member of the British House of Commons. At the same time an informal reception was given by the Montreal Protestant clergy to Rev. Bruce Taylor, the new pastor of St. Paul's Presbyterian Church, to Rev. Dr. Smyth, the new principal of Wesleyan College, and to Rev. Prof. Johnston Ross, a new addition to the staff of the Presbyterian College.

In a short speech the Rev. Mr. Horne explained that the reason he had stepped into political life was because his work as pastor of Whitefield's Chapel, London, had shown him that the laws in relation to the common people need much improvement. He outlined his fight for the license bill.

Spoke was given by the Y. M. C. A. and this evening in the Emmanuel Church. His text was "The Mission of the Modern Church." He pleaded for a simpler Gospel and for ampler mission, and demanded that the modern church reform and expression of worship. Above all, he urged that the modern church take positive stand in relation to the problems of modern civilization.

LUMBER UP IN SMOKE

SECRET POLICE KILLED STOLYDIN STAGGERING RUSSIAN SCANDAL

St. Petersburg, Sept. 21.—The inquiry into the assassination of Premier Stolypin at Kiev, with particular reference to the revolutionary and police elements involved, is being conducted personally by the minister of justice, M. Chicherov. Already there are indications of many ramifications in the case, and the department of police Verigin is under strong suspicion by the authorities, who hold that he is in a measure responsible for the crime.

Protecting the Czar.
