suspicion in the mind of the hon. Minister of Finance as to cause him to inquire into the situation. In addition to that we have the statement made by an hon. member of this House on his responsibility as a member, by one who lives right in the locality, who has been there all his lifetime and who ought to know the facts. Then, this hon. gentleman's statement is backed up by affi-davits and letters from some of the most respectable, the most responsible and the most intelligent men who have been navigating the St. Lawrence for the last 25 years, many of whom I know personally to be men of integrity and truthfulness, and men who know what they are talking about. If the hon. minister, with all this informa-tion in his possession, insists on carryng out this work he will be doing something that will be a scandal and a disgrace to this government.
