permanent institutions, most of which are affiliated with university schools of medicine.

Another reason for vacating these hospitals was that, being of temporary construction, such hospitals represent a greater fire hazard than do our permanent institutions.

In the case of Saskatoon we are anxious to relinquish this hospital, for the reasons stated, as soon as this can reasonably be done. We had made an agreement with the university of Saskatchewan for a wing on their proposed hospital which would provide us with 150 beds. I am informed that construction on that hospital has been temporarily suspended, but I am awaiting official advice from the government of Saskatchewan in this regard. It is therefore impossible at this time to set any date at which we propose to move our patients from their present institution into other quarters.

**CANADA FORESTRY ACT**

## PROVISIONS WITH RESPECT TO FOREST CONSERVATION—EXPERIMENTAL AREAS AND RESEARCH LABORATORIES

**Hon. J. A. MacKinnon (Minister of Mines and Resources)** moved that the house go into committee at the next sitting to consider the following resolution:

That it is expedient to present a bill to authorize the governor in council to establish as a national forest or as a forest experimental area lands belonging to His Majesty and to exercise control and management thereof and construct works therein; to establish and maintain forest research laboratories; to assist provinces or owners of forests and to enter into agreements respecting the protection and development of forest lands. The Minister of Mines and Resources is authorized to appoint temporary officers and employees for the carrying out of the provisions of the act.

Expenditures incurred are payable out of the consolidated revenue fund.

He said: His Excellency the Governor General, having been made acquainted with the subject matter of this resolution, recommends it to the consideration of the house.

**Mr. Speaker:** Is it the pleasure of the house to adopt the motion? Carried.
