UNEMPLOYMENT FIGURES, BRITISH COLUMBIA

Question No. 76-Mr. Christian:

- 1. How many are registered as unemployed in the province of British Columbia at the present time?
- 2. What were the figures covering those registered as unemployed in the said province one year ago?

Answer by: Hon. Michael Starr (Minister of Labour):

- 1. Information available from reports of local offices of the unemployment insurance commission pertains to the Pacific region which comprises the Yukon Territory and all but the northeastern portion of the province of British Columbia. As at September 19, 1957, the number of persons registered for employment at local offices in the Pacific region was 29,837.
- 2. The figure for the comparable date, September 20, 1956, was 15,619.

NATIONAL DEFENCE-REDUCTIONS IN EXPENDITURE ON TRAINING

Question No. 100-Mr. MacEachen:

1. What is the estimated reduction in national defence department spending resulting from the decision to cut the training days of the militia from sixty days to forty days?

2. What will this reduction amount to in respect

to the eastern command?
