DEATH OF EXTERNAL AFFAIRS EMPLOYEE, SAIGON

Question No. 29-Mr. Fisher:

1. Did an employee of the external affairs department die recently in Saigon?

2. If so, what was his name, career position, and original home address?

3. Where, when, and under what circumstances did the death take place?

4. Is the case completely closed? If not, what steps is the Canadian government taking to clear it up?

Hon. Sidney E. Smith (Secretary of State for External Affairs): Mr. Speaker, this question relates to an event that is supposed to have happened recently. I am not quite sure how one can interpret the word "recently" but I presume it refers to an event that happened in April of 1957. The answers to the questions are as follows:

(1)Yes, in April, 1957.

(2) A. E. L. Cannon, foreign service officer 4, Quebec city.

(3) Saigon, April 12, 1957. Murder.

(4) A thorough investigation was, of course, made but failed to establish responsibility. There is a possibility that further evidence may come to light and the case cannot, therefore, be considered as completely closed.
