Foreign Control of Canadian Industries Canadians who are concerned about job opportunities. The minister continued:

The Japanese have shown remarkable ability to manage their economy in the last 20 years.

A remarkable ability. They did it by a combination of things. One was by refusing to permit equity capital investment in Japan. They permitted debenture capital money that was lent but controlled rigidly the amount of equity capital invested in Japan. In other words, they restricted and almost prohibited foreign ownership of the industry and economy of the Japanese nation. They did this also by a curtailment to an almost minimal proportion of the amount of budgetary expenditures in Japan on matters such as defence, which are dead-end expenditures and drain off the wealth of the nation. In this regard, incidentally, following the end of the war and the end of the United States occupation, Japan did what we are advocating Canada should do, contrary to the statement of the minister that we are advocating a closed economy, which was a false statement in itself. The present Minister of Public Works went on to say:

Their growth has been spectacular. The Japanese people's standard of living has risen dramatically. To keep it rising will require exports which must be used to pay for imported raw materials.

That statement is semi-treasonable, to say the least. It is a shocking declaration from a minister of the Canadian government that we should export our raw materials to another country in order to ensure that that country is able to continue to increase steadily its standard of living. Is the minister not concerned about our standard of living and about jobs for the people here? Is he not concerned about improving the industries and the professions in this nation or about increasing the wealth of Canada? No; he is concerned about the wealth of Japan, and that attitude I classify as semi-treasonable, to say the least.

One of the areas in which we are involved in respect of foreign control is the financial. In the period 1957-58 we had a report by the Gordon royal commission on Canada's economic prospects. The royal commission recommended that we must ensure that our are concerned. The insurance, trust and loan of assistance.

companies represent a multi-billion dollar part of our economy. Yet to a great extent they are controlled by foreigners. To a great extent the decisions are made by people sitting in board rooms who are not even citizens of Canada, who have no responsibility to Canada and are not subject to any of the political pressures of Canada but are subject to the political and economic pressures in their own country.

As is well known, some of us in the New Democratic party have embarked on a filibuster program in respect of these insurance companies.
