Questions

Hon. Herb Gray (Minister without Portfolio): Mr. Speaker, the answer to part 1 is as follows: No. The CPR claims that the Pension Benefits Standards Act does not apply to its pension plan. It has not been considered appropriate for the government to make public any of the details of a private pension plan. The answer to part 2 is as follows: Yes. The CPR was given until May 12, 1970 to have its plan conform with the Pension Benefits Standards Act by the Superintendent of Insurance under the authority of that act. The answer to part 3 is as follows: See answer to part 1 and 2.

- 2. Is the Department considering some method whereby bidders in the Atlantic Provinces will be placed in a more equitable position for contracts awarded f.o.b. Montreal delivery?
- 3. In invitations to tender, will the Department in future consider specifying prices quoted for goods as f.o.b. an Atlantic Port?

Mr. Russell C. Honey (Parliamentary Secretary to Minister of Indian Affairs and Northern Development): 1. No. (a) N/A; (b) When goods are for shipment to the Eastern Arctic; they are marshalled at and shipped from Montreal under arrangements with the Department of Transport.

- 2. No, as it is not considered that bidders in the Atlantic Provinces are in a different position than those in other parts of the country.
- 3. No, the f.o.b. port for all such shipments is prescribed by the Department of Transport.
