QUEBEC-REQUEST FOR FEDERAL AID TO COMPLETE TRANS-CANADA ROUTE BETWEEN MONTMAGNY AND NEW BRUNSWICK

AIRCRAFT

STATUS OF ORDERS FOR LOCKHEED TRI-STAR AIRCRAFT

Hon. J. A. MacLean (Malpeque): Mr. Speaker, I should like to direct a question to the Minister of Transport. Would the minister inform the House as to the present state of Air Canada's orders for the Lockheed Tri-Star aircraft, whether these aircraft will be equipped with Rolls-Royce RB-211 engines, what delay there will be in delivery, and the effect, if any, on subcontracts which will be let to the Canadian aircraft industry?

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, I will try to answer the question briefly. The decision whether or not to proceed with the tri-jet program, that is, the decision by Lockheed to employ Rolls-Royce engines, has not yet been resolved. However, negotiations at the highest level are going on between the United States and Great Britain and the information, both public and private, is to the effect that these negotiations are progressing favourably. If agreement is reached between Lockheed and Rolls-Royce or between the two governments and the aircraft is therefore manufactured, it is anticipated that Air Canada will maintain its order for the tri-jets. This, of course, would result in the work already committed for in Canada in terms of subcontractors being carried on, as was the case before the Rolls-Royce troubles developed.
