HIGH WATER LEVEL IN GREAT LAKES—FEDERAL GOVERNMENT MEASURES TO AVERT DAMAGE

Mr. Terry Grier (Toronto-Lakeshore): Mr. Speaker, I should like to address my question to the Prime Minister as there would appear to be several departments of the government concerned, and in view of the seriousness of the situation. In light of the statement by an official of the International Joint Commission that nothing more can be done to control the rising water levels in Lake Ontario and the other Great Lakes and that further flooding is therefore inevitable, can the Prime Minister give the House assurances that all courses of action open to the federal government are being actively pursued in order to avert, so far as possible, flood damage, and will the Prime Minister or the appropriate ministers indicate to the House specifically what these steps are?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the answer to the first question is yes. The answer to the second is that various answers have been given by the Minister of the Environment who is responsible in the government for co-ordinating action in these areas.

Mr. Grier: In an effort to attract from the government benches more specific answers, may I put this supplementary question. Has the government taken the initiative to discuss joint preventive programs with the governments of the province of Ontario and/or Quebec? My question is again directed to the Prime Minister.

Mr. Trudeau: I will take notice of the question, Mr. Speaker. I have not had such discussions personally, but I will have to refer the question to the Minister of the Environment who has been retarded on his way in from the west coast and is expected later.
