(3) Where a motion referred to in subsection (2) is adopted by Parliament, the proposed regulation to which the motion relates may not be made.

(4) Where Parliament dissolves or prorogues earlier than twenty-five sitting days after a proposed regulation is laid before Parliament under subsection (1) and a motion has not been disposed of under subsection (2) in relation to the proposed regulation in Parliament, the proposed regulation may not be made.

(5) For the purposes of this section, "sitting day" means, in respect to Parliament, a day on which the House sits."
