vision of adequate terminal facilities at our great national ports has received and is receiving the attention of my advisers.

You have doubtless learned with satisfaction that the n.w government terminal elevator at Port Arthur 's completed, and that it has been in operation since October last. In conjunction with this, a system of interior terminal elevators has been begat, which will provide largely increased facilities for the farmers of the great grain producing provinces.

The International Conterence on Safety of Life at Sea, which has been 'u session in London for several weeks, has hat' under consideration questions of the highest im, ortance, and it is hoped that its deliberations may result in more effective measures for assuring the 'afety of the passengers and crews of ocean-gu'ing steamships. Representatives of Canada were appointed by Order in Council and have been in attendance at all sessions of the conference.

QUESTION OF PRIVILEGE.

Hon. Mr. CHOQUETTE — Before the Orders of the Day are called, I wish to bring to the attention of this House a letter which appeared in the Ottawa Citizen on the 16th inst. The letter is signed 'Andrew Holland,' and refers to the question of procuring a supply of water for the city of Ottawa. In the course of his letter he says:

It makes me tired to see the way the public are stampeded by the cry of doped water, and rounded up for an enormous expenditure of money on a municipal utility in a province entirely beyond our jurisdiction in which our civil rights are to be adjudicated on under a code entirely foreign to the people of Ontario, and where we shall be at the mercy of demagogues who know how to work on racial and religious weaknesses, to earn notoriety or pelf for their own miserable selves.

I wish to protest most emphatically against this expression, and the more so as I am told that the writer of this article is in the employ of the Senate. I hope it is not true, because if the Holland referred to is the gentleman who is sitting at the table to-day, I have the greatest esteem for him; nevertheless, if he is the writer of the letter I protest against this villainous article. We all know that a Bill was introduced in the Legislature of Quebec to provide a supply of pure water for the city of Ottawa. There are other pure articles which they will find in the province of Quebec besides the water. If the writer of this letter is the official reporter of the Senate, I hope he will withdraw this unkind remark as soon as possible.
