POWERS ALL SHIRK THE TASK.

No One is Willing to Undertake the
Crushing of Roumania.

London, Sept. 23.—"Nothing that
will rise from Secretary Hay's man-
agement of Roumania's treatment of
Jews unless somebody is willing to
crush Roumania, and no power seems
anxious to take on that task."

The foregoing quotation from the ut-
terances of an experienced British
statesman in the House of Commons
represents the real opinion of the
British Foreign Office on the subject
of the negotiations between America
and Europe.

Great Britain's backing up of the
United States in the Roumanian mat-
ter has only produced evidence that
the signatories of the Berlin treaty
absolutely refuse to take other than
merely sentimental action towards
relieving the persecutions of the Jews.

The exchange of views regarding
the American note solicited by Great
Britain has progressed sufficiently to
convince the Foreign Office here that
nothing material is likely to result.

Under Fruit Marks Act.

Colborne, Sept. 23.—Before Judge
Brennan last evening, Mr. Alex. Mc-
Neill, acting chief of the fruit division,
Department of Agriculture, Otta-
wa, charged the manager of the
Lakeland Fruit Preserving Company with
violating the Fruit Marks Act. Two of the charges
were in respect to twelve barrels of
apples inspected at Montreal, which
were found to be of inferior quality
to the quality of the fruit warranted.
The third charge was on com-
plaint from Winnipeg that ten barrels
of apples shipped to that city discol-
ored and were found to be of inferior
quality to the quality of the fruit war-
ranted.

The fourth charge was in respect
to the fact that the company had in-
fringed on the rights of the Dominion
of section 7 of the act. Con-
viction would mean a fine of \$10,
to which costs were added.

Several Radical Changes Made This
Year in the Annual Course
of Training.

OFFICERS TO BE INSTRUCTED
Only the Various Companies of the
Permanent Corps Attend in
Full Strength.

Niagara-on-the-Lake, Sept. 23.—All
during the day have the "skeleton"
regiments that will complete the camp
of instruction for Ontario being ar-
riving by boat and train. When all are here
it is expected that some 2200 men will
be under canvas for the twelve days'
training. There has been a radical
change made this year in the
annual course of training that
has hitherto seemed to straddle
en up and make soldiers of the
rural militia. This time it will be a
camp of instruction for officers, non-
commissioned officers and men. In-
stead of assembling in full strength
each regiment ordered to camp will
send 1 lieutenant, 1 major, 1 adjutant,
1 quartermaster, 1 company
officer, 1 sergeant, 1 corporal,
sergeants per company, 3 corporals
per company, 2 privates per com-
pany and 22 privates from the reg-
iment for fatigue duties and one of-
ficer selected with a view to inspec-
tion in musketry. The various com-
panies of the permanent corps attend
in full strength.
