The warm tributes we just heard are a great comfort to us and will help bear the grievous loss we are experiencing as the result of the tragic event which caused the premature death of our young leader, Mr. André Fortin, whom we had learned to know as a dynamic organizer, aware of his duties and responsibilities.

It was at the end of a four-day tour of British Columbia from where he returned with much enthusiasm about his meetings with the supporters and organizers of our party that André undertook his fatal trip from Ottawa to his Victoriaville home when fatigue overcame him and put an end to a very promising career.

André Fortin was not only the national leader of the Social Credit Party of Canada but he was to us all a friend. He always showed an acute sense of timeliness and he was gifted with a great clarity of mind which enabled him to find the right word at the right moment. I think that under the circumstances it would be appropriate to quote an excerpt from the last speech he delivered in the House of Commons on June 15, 1977:

If we want law and order, we will adopt mechanisms and legislation proving that we are serious and consequently we will punish those who violate the law and encourage those who abide the law. I think that is essential.

André Fortin will remain a friend in the memory of all those who worked with him or came in contact with him in political quarters, and in the memory of all Canadians, whatever their social standing. During his short political career, he gave the example of a model worker who knew the needs and yearnings of the Canadian people.

To his wife, his children, his constituents of Lotbinière and his relatives, we extend our deep sympathy.

I believe every citizen of the country should realize it was his tremendous devotion and commitment to duty as a member and as the leader of a major party in this House which contributed to his death and should pay him tribute because of that.
